Fundación MAPFRE (hereinafter, "the Foundation"), a Spanish non-profit organization with registered office at Paseo de Recoletos 23 in Madrid (Spain) and tax identification number G 28520443, announces the second photography workshop of *Get Real (Open your eyes!)*, an annual program of photographic workshops to be held at the KBr Fundación MAPFRE Photography Center (Avenida del Litoral, 30, 08005, Barcelona) and with which the Foundation reiterates its support for training in the field of artistic photography, with the help of renowned photographers.

## Candidates

This fourth workshop, entitled *Clarifying your vision: how to make your photography project stand out* and taught by artist Simon Norfolk, is open to national or international artists of legal age who are interested in addressing and working on some of the most relevant themes in contemporary photographic practice.

## Applying to participate in the workshop

Candidates interested in participating must submit their own application in digital format using the online form available on the KBr Fundación MAPFRE website [kbr.fundacionmapfre.org], to which the following documentation must be attached:

- Photocopy of the candidate's valid national identity document, passport or identity card.
- Contact information (email, address and telephone number).
- Short paragraph answering two questions: Why are you a photographer? Why do you want to attend the workshop? (300 words maximum).
- Selection of images (between 15 and 20) from a project in the development phase that the candidate would like to work on during the workshop, whose author is the candidate and which is relevant to him/her, something with which the candidate feels identified.

The candidate's projects must be original and therefore they must vouch to Fundación MAPFRE for the authorship and originality of the work, declaring that they are the sole and exclusive owner in full ownership and without any limitation whatsoever.

The candidates are responsible for complying with the legal provisions in force regarding intellectual property and the right to one's own image, and must ensure that third parties cannot claim any rights with respect to the project submitted to the competition. In any event, the candidates will be responsible for any claims arising from image rights and third party rights.

The documentation must be submitted in PDF format in a single delivery. The PDF must have a single orientation (vertical or horizontal). Maximum size 15 MB.

The application may be submitted in English, Catalan or Spanish.

The period for the presentation of applications is 33 days, from April 28, 2025, to May 30, 2025, inclusive.

Applications that are incomplete on the closing date of the above-mentioned submission period will not be accepted.

Fundación MAPFRE reserves the right to disqualify applications that do not comply with these terms and conditions, especially those that contain inaccurate information.

## Participant selection and notification process

Fundación MAPFRE, with the help of its designated experts, will review all the applications and select the most suitable to participate in the photography workshop entitled *Clarifying your vision: how to make your photography project stand out*.

The 15 participants will be selected by Fundación MAPFRE, which will notify each of the shortlisted candidates by email on June 2, 2025. During the deliberation process, the experts appointed for this purpose by Fundación MAPFRE will have access to all application documents.

Fundación MAPFRE may, exceptionally, extend the deadline for application submission, provided that this decision is taken before the shortlisted candidates are notified. Such an extension would be announced via the Fundación MAPFRE website and its profiles on social networks.

Fundación MAPFRE reserves the right not to assign or offer all of the 15 places open for the workshop, in the event that the projects are not of sufficient quality or do not meet the specifications of these terms and conditions.

Fundación MAPFRE may adopt any initiatives it deems necessary to verify the information on the entries submitted.

Fundación MAPFRE may withdraw the status of a selected photographer and designate a replacement in the event that they do not formalize their participation in the workshop.

Shortlisted candidates will receive an official email from Fundación MAPFRE and must expressly accept their participation in the workshop by the same means (i.e., by sending an email to Fundación MAPFRE) within a period of no more than 5 working days following receipt of this communication.

In order to formalize their place, each of the pre-selected candidates who have expressly agreed to participate in the workshop must pay the registration fee, as described below, in the following point entitled "Workshop".

No further correspondence or communication will be entered into with unsuccessful applicants. Likewise, no information about the selection process or the other applications received will be provided.

Documentation from incomplete or unsuccessful applications will be destroyed within three months of the publication of the participant list.

## Workshop

Successful candidates will be offered a place in the four-day workshop taught by Simon Norfolk, which will take place from June 19 to 22, 2025, inclusive. Over those four days, the participants will share an intensive session with the artist Simon Norfolk and will receive from Norfolk personalized feedback on their work. By agreeing to participate, the selected candidates undertake to:

- Pay the registration fee, by credit card, of the amount of 200€ (TWO HUNDRED EUROS). This payment can be made through the link that will be provided to the selected candidates once they have been notified of their participation in the workshop. From this notification, the selected candidates will have 5 working days to confirm their participation and make the payment. Once payment has been made, the candidate becomes a participant in the workshop. However, if after this period, the pre-selected candidate has not paid the corresponding registration fee, it is understood that they have withdrawn and Fundación MAPFRE may either award the vacant place to another candidate or leave it vacant.
- Attend the entire workshop, over the course of the four days, by participating in it, carrying out the proposed activities and taking part in the practical sessions, as well as in all the activities suggested by the artist teaching the workshop. Upon completion of the above, Fundación MAPFRE will issue a certificate evidencing participation in the workshop.

## Data protection

The participant is informed of the processing of the personal data provided, as well as their image and voice and those obtained during the course of the *Get Real! Workshops (Open your eyes!)* for the purpose of managing this call and their participation in the same, as well as their promotion in the media and social networks, Fundación MAPFRE being the entity responsible for the processing. Communications to third parties or transfers to third countries will only be made when they are essential for the fulfilment of the aforementioned purposes, and in any case under the terms indicated in the Additional Information.

No information will be provided on the selection process or on the rest of the candidatures received.

If the data provided are of individuals other than the participant, the participant guarantees to have their consent before providing them, previously informing them of the terms of data protection established in this document. In addition, the Participant guarantees the accuracy and veracity of the personal data provided, undertaking to keep them duly updated and to inform Fundación MAPFRE of any changes that may occur in them.

The Participant declares that he/she is over eighteen years of age. In the event that the report or documentation submitted contains data of minors, the participant, as the parent or guardian of the minor, expressly authorises the aforementioned processing and transfer of such data for the aforementioned purposes.
